# **Heating Mechanic License Application**

Contractors must be licensed by Pikes Peak Regional Building Department ("PPRBD") prior to consulting for, contracting for, or performing work that requires a permit.

# **Heating Mechanic I (Fitter)**

This license allows the holder to engage in the installation and repair of gas piping systems. An applicant for Heating Mechanic I license shall have one (1) year experience in gas pipe fitting/installing and servicing. The applicant shall demonstrate proficiency in the use and calibration of a combustible gas indicator. All work must be performed under the direction of a Mechanical Contractor A, B, C (Gas Piping), or D. (RBC204.4.1)

## Heating Mechanic IV - HVAC Service Technician

This license allows the holder to engage in the repair and servicing of heating, ventilation, and air conditioning equipment and systems when employed by, and under the direction of a Mechanical Contractor A, B, C (except for Residential Remodeling), or D. Work must correlate to the type of license(s) held by the Mechanical Contractor. The holder may also repair leaks in gas piping systems that do not entail alteration or the complete replacement of the piping. This license requires proficiency in the use and calibration of a combustible gas indicator and a carbon monoxide detection instrument. (Note: License renewal will require proof of satisfactorily completing six (6) hours or more of approved technical training.) (RBC204.4.4)

# The items listed below are required for consideration of your license application:

Application form - Pages 3-4 must be filled out completely or the application will not be accepted. *Attaching the applicant's resume is recommended.
A non-refundable \$50 application/processing fee is due at the time the application is submitted. *The fee is payable by cash, check, or credit card.
Copy of current Driver License or photo ID card issued by a state or federal government.
Approved and passed ICC National Standardized Contractor Exam, if applicable.
Attach a copy of Combustible Gas Indicator Certificate.
Attach a copy of Carbon Monoxide Detection Instrument Certificate.

#### \*Please Note:

A name-based judicial record check will be performed by PPRBD. The name-based judicial record review process may affect when your application will be reviewed by the Licensing Committee.

# **License Review**

The Licensing Committee considers license requests and makes recommendations for approval, conditions, or denials to the Board of Review. All required documents, exam, name-based judicial record review, and application fee must be complete before the license request is placed on the Licensing Committee meeting agenda. The deadline to submit the completed application and all required documents to PPRBD is three (3) weeks prior to the Licensing Committee meeting. The deadline to submit supplemental application documents to PPRBD, including but not limited to additional relevant experience, is ten (10) calendar days prior to the Licensing Committee meeting; any documents submitted to PPRBD past the 10-calendar day deadline will result in the license application remaining in "incomplete" status and its possible consideration at the next month's Licensing Committee meeting. No exceptions to this requirement shall be considered by PPRBD staff. License approvals, conditions, or denials are recommendations by the Licensing Committee and must be approved by the Board of Review, which meets the following week.

#### License Issuance

Within sixty (60) days of the Board of Review's approval, the applicant must obtain the license. After sixty (60) days, an unclaimed license is voided and the entire application file is discarded, and the applicant must reapply. Work cannot be consulted for, contracted for, or performed until the license is issued.

#### **License Fees**

The annual license fee of \$10 is due. The nonrefundable fee is payable by cash, check, or credit card to Pikes Peak Regional Building Department.

#### **License Expiration & Renewal**

Licenses are valid for 12 months from the date of issuance, and expire on the last day of the month in which the license was issued. NOTE: Heating Mechanic IV (HVAC Service Technician) license renewal requires proof of satisfactorily completing six (6) hours or more of approved technical training.
