PROCEEDINGS:

The Licensing Committee meeting was conducted in a hybrid form, allowing Committee members, Department staff, and the public to attend in person at the Pikes Peak Regional Development Center, 2880 International Circle, Colorado Springs, Colorado 80910, Hearing Room on the Upper Level, or virtually via a program called Microsoft Teams live events, which is accessible via Pikes Peak Regional Building Department's website Boards & Committees' page at: https://www.pprbd.org/Information/Boards.

1. CALL TO ORDER: DETERMINATION OF A QUORUM

Chair Steve Lepine called the meeting to order at 9:00 a.m.

2. CONSIDERATION OF THE MARCH 9, 2023 LICENSING COMMITTEE MINUTES

A motion was made by David Rojewski to **APPROVE** the March 9, 2023 Licensing Committee Minutes as written, seconded by Zachary Taylor; the motion carried unanimously.

3. **COMPLAINT(S)**

Conduct of Hearing.

Rules. Hearings need not be conducted according to the technical rules relating to evidence and witnesses.

Oral Evidence. Oral evidence shall be taken only on oath or affirmation.

Hearsay Evidence. Hearsay evidence may be used for the purpose of supplementing or explaining any direct evidence, but shall not be sufficient in itself to support a finding unless it would be admissible over objection in civil actions in courts of competent jurisdiction in this State.

Admissibility of Evidence. Any relevant evidence shall be admitted if it is the type of evidence on which responsible persons are accustomed to rely in the conduct of serious affairs, regardless of the existence of any common law or statutory rule that might make improper the admission of any evidence over objection in civil actions in courts of competent jurisdiction in this State.

Exclusion of Evidence. Irrelevant and unduly repetitious evidence shall be excluded.

Rights of Parties. Each party shall have these rights among others:

- **1.** To call and examine witnesses on any matter relevant to the issues of the hearing;
- **2.** To introduce documentary and physical evidence;
- **3.** To cross-examine opposing witnesses on any matter relevant to the issues of the hearing;
- **4.** To impeach any witness regardless of which party first called to testify;
- **5.** To rebut the evidence against the party;
- **6.** To represent the party or to be represented by anyone of the party's choice who is lawfully permitted to do so.
- a) A complaint has been brought against David Halaseh and Gerald Salinas, Examinees for Comprehensive Maintenance Solutions LLC, d/b/a Colorado Comfort Heroes, by Peter Adasek for performing work at 1642 Goldpeak Court, Colorado Springs, Colorado without the required permit(s) and outside the scope of their license or registration.

Peter Adasek ("Adasek") appeared in person and was sworn in. David Halaseh ("Halaseh") and Gerald Salinas ("Salinas") appeared in person and were sworn in. Peter Halaseh appeared in person as a witness and was sworn in. He stated he is an employee and co-owner of Comprehensive Maintenance Solutions LLC ("Comprehensive").

Adasek stated he had a boiler installed in his home by Comprehensive on July 2, 2022, but the inspection was not completed until March 29, 2023. He stated he was unhappy with the installation because one side of the boiler was missing, and he was told the manufacturer was no longer in business so Comprehensive was unable to get parts for the boiler. He was informed that they would have a custom panel ordered for the boiler, but what he received was a generic panel, which he was very unhappy with. Adasek stated there was also a pressure valve that had not been connected, which was not resolved until after the inspection by the Department. It was also his understanding that a carbon monoxide test had not been completed by the inspector, and he was concerned for his safety.

Adasek stated he was unable to find a serial number on the boiler and believes the boiler was not a new boiler as it had rust on the inside of the boiler. He introduced on the record a 12-page document (without objections) consisting of photographs of the boiler.

Halasek stated the side panel of the boiler was damaged when it was installed, but the manufacturer had gone out of business, so he was unable to purchase parts for the boiler. He stated he had a new side panel fabricated and installed it on Adasek's boiler. He stated his father was living with Adasek, so he would not have taken a chance of endangering his father or Adasek by installing a faulty boiler. Halasek said he installed a CO2 alarm in Adasek's mechanical room. Further, the inspector had a CO2 detector on him when he did the inspection; carbon monoxide had not been detected. He stated he would email the serial number for the boiler to Adasek so he would have it for his records.

Matthew Matzen stated Comprehensive has been in business since on or around November 14, 2016; it has a Heating A License and a Plumbing A Registration. It has a record of 211 permits: 1 A Status Permit; 202 completed permits; 1 voided permit; and 7 open permits. 187 of the total permits are mechanical permits; 24 are plumbing permits. Comprehensive's insurance is in good standing.

A motion was made by Tim Toussaint to place a One-Year Incident Report in the files of David Halaseh, Gerald Salinas, and Comprehensive Maintenance Solutions LLC, d/b/a Colorado Comfort Heroes for performing work at 1642 Goldpeak Court, Colorado Springs, Colorado without the required permit(s), seconded by Zachary Taylor; the motion carried unanimously.

Virjinia Koultchitzka advised the parties to the complaint of their appeal rights: 30 calendar days from the decision of the Committee to file a written appeal with the Department in accordance with Section RBC101.7 of the Pikes Peak Regional Building Code, 2017 Edition, as amended (the "Code"). Further, she stated the Department has authority, pursuant to Section RBC103.12 of the Code to issue administrative fines; the Department retains such right, and fine(s) may be imposed.
